



CONSTRUCTION EMPLOYMENT DECLINES IN 40 STATES BETWEEN APRIL AND MAY AS SOARING MATERIAL COSTS, SUPPLY-CHAIN DISRUPTIONS IMPEDE RECOVERY

June 23, 2021

New York and Vermont Iowa Post Biggest Monthly Losses, While Florida and Oklahoma Top Gainers; Texas and Wyoming Have Worst Job Losses from the Pandemic, as Utah and Idaho Add the Most

Construction employment in May remained below the April level in 40 states and the District of Columbia, according to an <u>analysis</u> by the Associated General Contractors of America of government employment data released today. Association officials said skyrocketing materials prices and excessive delays in receiving key construction supplies were holding back the industry's recovery.

"Today's numbers show that impacts from the pandemic on demand for projects and on materials costs and the supply chain are weighing down construction in most parts of the country," said Ken Simonson, the association's chief economist. "In the few states where industry employment has topped the prepandemic levels of February 2020, most gains are likely attributable more to demand for homebuilding and remodeling than to most categories of nonresidential building and infrastructure projects."

From April to May, construction employment decreased in 40 states and D.C., increased in only eight states, and held steady in Maryland and Utah. The largest decline over the month occurred in New York, which lost 5,900 construction jobs or 1.6 percent, followed by Illinois (-5,600 jobs, -2.5 percent) and Pennsylvania (-3,300 jobs, -1.3 percent). The steepest percentage declines since April occurred in Vermont (-3.9 percent, -600 jobs), followed by Maine (-3.5 percent, -1,100 jobs) and Delaware (-3.0 percent, -300 jobs).

Florida added the most construction jobs between April and May (3,700 jobs, 0.6 percent), followed by Michigan (1,600 jobs, 0.9 percent) and Minnesota (1,200 jobs, 0.9 percent). Oklahoma had the largest percentage gain for the month (1.3 percent, 1,000 jobs), followed by Minnesota and Michigan.

Employment declined from the pre-pandemic peak month of February 2020 in 42 states and D.C. Texas lost the most construction jobs over the period (-49,100 jobs or -6.3 percent), followed by New York (-45,200 jobs, -11.1 percent) and California (-30,800 jobs, -3.4%). Wyoming recorded the largest percentage loss (-15.3 percent, -3,500 jobs), followed by Louisiana (-15.1 percent, -20,700 jobs) and New York.

Among the eight states that added construction jobs since February 2020, the largest pickup occurred in Utah (5,000 jobs, 4.4 percent), followed by Idaho (3,400 jobs, 6.2 percent) and South Dakota (1,200 jobs, 5.0 percent). The largest percentage gain was in Idaho, followed by South Dakota and Utah.

Association officials noted that cost increases and extended

lead times for producing many construction materials are exacerbating a slow recovery for construction. They urged the Biden administration to accelerate its timetable for reaching agreement with allies on removing tariffs on steel and aluminum, and to initiate talks to end tariffs on Canadian lumber.

"Federal officials can help get more construction workers employed by removing tariffs on essential construction materials such as lumber, steel and aluminum," said Stephen E. Sandherr, the association's chief executive officer. "These tariffs are causing unnecessary harm to construction workers and firms, as well as to the administration's goals of building more affordable housing and infrastructure."

DODGE MOMENTUM INDEX JUMPS IN MAY

Commercial planning pushes Index to seventh consecutive monthly gain

HAMILTON, New Jersey – June 7, 2021 – The Dodge Momentum Index moved 9.1% higher in May to 178.0 (2000=100), up from the revised April reading of 163.2. The Momentum Index, issued by <u>Dodge Data & Analytics</u>, is a monthly measure of the first (or initial) report for nonresidential building projects in planning, which have been shown to lead construction spending for nonresidential buildings by a full year.

May's jump was the result of a large increase in commercial planning activity, which posted its strongest month-over-month increase since October 2017. Institutional planning, mean-while, fell by less than one percentage point.

Commercial planning had been in a holding pattern over the last four months, but broke out in May due to several sizable data center, office, and warehouse projects that peaked in a 13year high for the commercial component of the Momentum Index. While essentially flat in May, institutional planning remains at levels not seen since 2009. On a year-over-year basis, both commercial and institutional planning were up from May 2020 (38% and 47% respectively). The Momentum Index overall was also 41% higher than in May 2020.

A total of 21 projects with a value of \$100 million or more entered planning during May. The leading commercial projects were a \$500 million conversion of a coal-burning power plant to a data center in Barker NY and a \$450 million office campus in Los Angeles CA. The leading institutional projects were the \$250 million Houston Methodist Hospital Campus in Cypress TX and the \$250 million Landmark Center in Boston MA.

The rising trend in planning activity is a good sign that the economic recovery is starting to spread into the construction sector. However, these projects are unlikely to have an impact on construction starts this year. Rising material prices and a continued shortage of skilled labor have led to project delays. On the upside, construction starts are shaping up for a healthy increase in 2022.


OSHA INITIATIVE SEEKS TO PROTECT MANUFACTURING WORKERS IN MIDWEST FACILITIES FROM HAZARDOUS NOISE LEVELS

On June 1, 2021, the Occupational Safety and Health Administration (OSHA) Region V office established a regional emphasis program (REP) focusing on occupational noise exposure in the workplace (https://www.dol.gov/sites/dolgov/files/OPA/ newsreleases/2021/06/OSHA2021994NOISEREP.pdf). The initiative is meant to encourage employers to take steps to identify, reduce and eliminate hazards associated with exposure to high levels of noise. The REP comes in the wake of a recent study by the Bureau of Labor Statistics (BLS), which found that the national average hearing loss rate for all private manufacturing is 8.6 cases per 10,000 full time workers. In addition, the study found that over half of workers in production occupations did not use personal protective equipment to mitigate workplace noise exposure (https://www.bls.gov/iif/oshwc/osh/ os/snr08 00 2019.xlsx).

In response to these alarming rates, OSHA Region V, which includes Illinois, Indiana, Michigan, Minnesota, Ohio and Wisconsin, has proposed to accomplish this REP through outreach and enforcement activities. The outreach proposed will include the following:

- Targeted presentations, speeches, meetings and/or training sessions with employers/stakeholders;
- Letters/mailings to employers, professional associations, local safety councils, apprenticeship programs, local hospitals and occupational health clinics;





- News releases through local newspapers, safety councils, and/or industrial hygiene organizations;
- Use of current social media methods;
- Leveraging existing partnerships and alliances; and
- Encourage the use of OSHA's On-Site Consultation Program and compliance assistance resources.

The outreach, which began on June 1, 2021, will be followed by enforcement actions no sooner than three (3) months after OSHA's initial outreach efforts began. Starting in August, manufacturing employers located in Region V with hearing loss rates higher than the national average can expect inspections of their workplace. The REP empowers OSHA to conduct inspections for all complaints and referrals in industries covered by the REP. In addition, OSHA will conduct inspections based on a randomized programmed inspection list, as prepared by the National Office. All selected establishments, regardless of size, will be inspected. During those inspections, CSHOs will review OSHA 300 injury and illness logs; walk around the facility to obtain sound level meter readings; conduct full shift noise monitoring and issue citations for violations of 29 CFR 1910.95. As stated, the REP gives OSHA probable cause to the extent an employer has a hearing loss rate higher than the national average to enter the workplace and walk around the facility to take sound level meter readings. Of course, they will also cite employers for any other safety violations they observe during this walk around.

You need to be sure that you have evaluated any noise exposure for your employees. If you determine that you have noise exposures in excess of 85 dBA, you need to have in place a written hearing conservation program. If your employees are exposed to noise in excess of 90 dBA, you must have a written program in compliance with the requirements of OSHA Standard 1910.95. U.S. DEPARTMENT OF LABOR OUTLINES UPCOMING WORKER-CENTERED PROTECTIONS IN BIDEN-HARRIS ADMINISTRATION SPRING REGULATORY AGENDA

<u>tive Order 12866</u> – the U.S. Department of Labor is announcing a series of anticipated regulatory actions to ensure the wellbeing of these workers, employers and others.

The order requires the publication of an agenda of regulations that contains a listing of all the regulations the Department of Labor expects to have under active consideration for promulgation, proposal or review during the coming one-year period.

The department's portions of the agenda published today include actions to implement the Biden-Harris Administration's priorities in the areas of economic relief, wages, climate change and racial equity. It also includes proposals to withdraw the obstacles to protecting and strengthening workers' economic security and civil rights that the prior administration put in place.

Regulatory protections include:

- Increasing the Minimum Wage for Federal Contractors: In response to Executive Order 14026, "Increasing the Minimum Wage for Federal Contractors," the department's Wage and Hour Division is drafting regulations that will increase the hourly minimum wage rate paid by parties that contract with the federal government to \$15 for those employees working on or in connection with a covered federal government contract.
- Fairness for Workers Who Rely on Tips: The Wage and Hour Division is also engaged in rulemaking to address the economic security of tipped workers.

- Modernizing the Davis-Bacon and Related Acts Regulations: The DBRA requires the payment of locally prevailing wages and fringe benefits to laborers and mechanics as determined by the department. The Wage and Hour Division is proposing to update and modernize the regulations implementing the DBRA to provide ensure workers are truly paid prevailing wages on federal construction contracts.
- Re-examining our approach to investments that tackle climate change: To implement Executive Order 13990, "Protecting Public Health and the Environment and Restoring Science to Tackle the Climate Crisis," and Executive Order 14030, "Climate-Related Financial Risks," the Employee Benefits Security Administration is undertaking a review of regulations under Title I of the Employee Retirement Income Security Act, including "Financial Factors in Selecting Plan Investments" and "Fiduciary Duties Regarding Proxy Voting and Shareholder Rights."

Prior rulemakings are also being proposed for withdrawal because of their deleterious effects on the lives of working people, including a rule on labor standards in apprenticeship.





PRODUCER PRICES FOR CONSTRUCTION MATERIALS AND SERVICES JUMP 24 PERCENT OVER 12 MONTHS, THREATENING CONTRACTORS' SOLVENCY AND WORKERS' JOBS

June 15, 2021

The cost of goods and services used in construction climbed by a record-setting 4.3 percent in May and 24.3 percent over the past 12 months, jeopardizing contractors' solvency and construction workers' employment, according to an <u>analysis</u> by the Associated General Contractors of America of government data released today. Association officials urged the Biden administration to move more quickly to end tariffs and quotas that are adding to construction materials costs and availability problems.

"The increase in producer prices for construction materials over the past year far outstrips contractors' ability to charge more for projects," said Ken Simonson, the association's chief economist. "That gap means contractors are being hit with huge costs that they did not anticipate and cannot pass on."

The 24.3 percent increase in prices for materials used in construction from May 2020 to last month was nearly twice as great as in any previous year, Simonson said. Meanwhile, the producer price index for new nonresidential construction—a measure of what contractors say they would charge to erect five types of nonresidential buildings—rose only 2.8 percent over the past 12 months, as contractors held their profit expectations down in order to compete for a limited number of new projects.

Items with especially steep price increases over the past year covered a wide range of materials, including products made from wood, metals, plastics, and gypsum. The producer price index for lumber and plywood more than doubled—rocketing 111 percent from May 2020 to last month. The index for steel mill products climbed 75.6 percent, while the index for copper and brass mill shapes rose 60.4 percent and the index for aluminum mill shapes increased 28.6 percent. The index for gypsum products such as wallboard climbed 14.1 percent. Fuel costs, which contractors pay directly to operate their own trucks and off-road equipment, as well as through surcharges on freight deliveries, have also jumped.

Association officials said the Biden administration can provide immediate relief from some of the price pressures by ending tariffs on Canadian lumber, along with tariffs and quotas on steel and aluminum from numerous countries. Officials said the administration took a first step today by announcing agreement on a working group with the European Union that will aim to end tariffs on steel and aluminum from the EU by the end of 2021 but that much more tariff relief is needed, and sooner. The administration should also end the duty on Canadian softwood lumber, instead of doubling the rate, as the Commerce Department has proposed, the officials added.

"The administration is right to recognize that ending tariffs on our allies is good policy," said Stephen E. Sandherr, the association's chief executive officer. "But there is no reason to wait six months to adopt good measures. The president should go further, by ending tariffs and quotas on steel and aluminum from other trading partners as well as the European Union."

STATEMENT BY U.S. SECRETARY OF LABOR WALSH ON THE MAY JOBS REPORT

WASHINGTON, DC – U.S. Secretary of Labor Marty Walsh issued the following statement on the May 2021 Employment Situation Report:

"Today, the Bureau of Labor Statistics reported that the American economy added 559,000 jobs in the month of May, and the unemployment rate was 5.8 percent, down from 6.1 percent in April to the lowest point it has been since March of 2020.
